Judge Henington called the meeting to order at 9:30 a.m.; the following Elected Officials were present:

Commissioner Morrow moved to approve May 14, 2024, minutes. Commissioner Westermann seconded the motion; motion passed 4-0.

Commissioner Morrow announced the Chief Appraiser Raymond Herrera has resigned. A new Chief Appraiser has been assigned. There are currently 300 protests filed. Judge Henington announced the Appraisal District office has moved to 1604 West Highway 90 in Alpine.

9. Review, discuss and take possible action for an authorization to issue requests for proposal for administrative services (RFP) and requests for qualifications for engineering services (RFQ) for grant pre-application (Phase I), application (Phase II), and implementation services for Texas Community Development Grant Program for 2025/2026 Community Development Fund (and all eligible activities per the application guidance) as administered by the Texas Department of Agriculture.

#### A. Community Block Grant Data Sheet

Samantha Chumley, GrantWorks Service Manager, presented information on the Community Development Block Grant. The grant is eligible for the maximum of \$500,000. There will be another opportunity in the future for \$1,000,000 from the Colonia Grant to help with water, sewer, and roads. Judge Henington moved to approve the application for the Community Development Block grant. Commissioner Colando seconded the motion; motion passed 4-0.
