Commissioner Ortega moved to approve the minutes of the Regular Commissioners Court meeting of September 23, 2025. Commissioner Colando seconded the motion; motion passed 5-0.

B. Special Commissioners Court Meeting of September 30, 2025

Commissioner Westermann moved to approve the minutes of the Regular Commissioners Court meeting of September 30, 2025. Commissioner Ortega seconded the motion; motion passed 5-0.

6. Report from City of Alpine representative; discussion only, no action required

Rick Stephens, Ward 5 City Council Member, presented an update from the City of Alpine.

Commissioner Ortega announced that the 6th Annual John Prine Tribute had a good turnout, and that the Marathon 2 Marathon is coming up soon.

Commissioner Morrow announced that 2025 Lone Star Cowboy Poetry Gathering will be split between Alpine and Bastrop, due to a shortage of hotel rooms available in Alpine.

8. Review, discuss and take action on the FY 2026 Jury Plan for Brewster County

A. New Jury Plan 2025

Sarah Fellows Martinez, District Clerk, presented the FY2026 Jury Plan for Brewster County. District Clerk Martinez advised the Commissioners that if approved, the new plan will reinstate the approval of online questionnaires for prospective jurors which can help avoid issues notifying jurors when court is cancelled abruptly. Commissioner Ortega moved to approve the FY26 Jury Plan as presented. Commissioner Colando seconded the motion; motion passed 5-0.

9. County Judge Report - Information and Action Items

A. Review, discuss and take action to approve resolution applying for FY 2026 TIDC Formula Grant Commissioner Colando moved to approve the resolution applying for FY26 TIDC Formula Grant with the correction of Auditor to Comptroller. Commissioner Ortega seconded the motion; motion passed 5-0.

B. Review, discuss and take possible action designating a specific mailing (including electronic) address for the purposes of handling requests under the Public Information Act - Government Code 55.234

A. Plat application for Lakeside Cottages, Lajitas, Texas

Judge Henington announced the next regular Commissioners Court meeting on October 28, 2025, at 9:30 AM.


19. Adjourn
